

# Bull City Race Fest VIP Giveaway Official Rules

By entering into this Sweepstakes, I accept the terms and conditions set forth in these Official Rules. ("Capstone"), Delta Airlines, Inc., and First Horizon Bank (collectively, the "Sponsors"). No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning. Entries submitted before or after the Entry Period will not be eligible. **Notification and Requirements of Potential Winners:** Sponsor will attempt to notify the potential winner within five (5) business days of the drawing by email. If a potential winner does not respond within seven (7) calendar days after the notice is sent, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only five (5) alternate potential winners will be contacted.
